 - 1.No lunch break on company registration and certification or duplication of registered documents.
 - 2. Take form completion service measures, if your company wish to apply for certification or duplication of registered documents to our counters. (Our clerk helps to fill in the form if name signed.)
 - 3.Establish application service by fax on certification or duplication of registered documents. If you apply by fax (049-2316390), we deal with it and respond you by post immediately.
 - 4.Over 90% cases of company registration and record request settled within one or two days. Applying at counters with correct application documents, pick up within 24 minutes.
 - 5.Make use of 'One-stop window' and 'Review on the spot' to offer more convenience to the applicant.
